

# Unpacking Data Literacy in Mathematics Education: A Systematic Review of Research Trends and Thematic Developments

#### **Abstract**

Data literacy has become an essential skill in the digital era, yet its integration into mathematics education remains fragmented. As data-driven decision-making gains prominence in instructional practices, understanding how teachers engage with data literacy is crucial for enhancing student learning outcomes. This systematic review synthesizes research on data literacy in mathematics education from 2009 to 2024, employing the PRISMA (Preferred Reporting Items for Systematic Reviews and Meta-Analyses) framework to ensure a transparent and replicable study selection process. Bibliometric analysis was conducted using VOSviewer to map research trends, key themes, and collaborative networks in the field. The findings indicate a growing emphasis on teacher competency in data literacy, with studies highlighting its correlation with effective instructional strategies and improved learner engagement. Additionally, the review reveals that teachers' perceptions and confidence in utilizing data significantly influence their pedagogical approaches. The results also suggest that institutional support, professional development, and leadership play a critical role in fostering a data-literate teaching workforce. Despite an increasing body of research, gaps remain in understanding how data literacy directly impacts long-term student achievement. The study underscores the need to integrate data literacy within broader educational frameworks and policies to enhance mathematics instruction. Future research should further explore contextual challenges, intervention strategies, and the role of technology in strengthening data literacy among educators.

# Introduction

Data literacy has emerged as a fundamental skill in the digital society (Carmi et al., 2020). The vast amount of data continuously generated in the digital world is only beneficial when individuals possess the necessary data literacy skills to access, collect, analyze, interpret, and use data effectively (Pangrazio & Sefton-Green, 2020). However, despite the rapid increase in data generation, the advancement of data literacy skills has not kept pace (Mosia et al., 2024; Henderson & Corry, 2021).

This gap in data literacy has significant implications for mathematics education, as it limits the effective use of data for decision-making and instructional improvement (Cowie & Cooper, 2017). Henderson and Corry (2021) emphasize that data literacy is crucial in mathematics education, particularly for teachers who require strong data literacy skills to enhance students' performance. Additionally, fostering a culture of data literacy is essential for both teaching and learning mathematics. As a result, the

recognition of the importance of improving data literacy skills, especially within mathematics education, is growing (Raffaghelli & Stewart, 2020). Early integration of data literacy skills into undergraduate teacher education programs has the potential to promote effective data management practices and enhance instructional quality (Womack, 2015; Pothier & Condon, 2019).

With the increasing acknowledgment of data literacy's role in mathematics education, a growing body of literature has emerged on the topic (Dodman et al., 2023; Egara & Mogege, 2024; Egara et al., 2025; Mosia et al., 2025a,2025b,2025c). Research on data literacy in mathematics education spans various educational contexts, including formal schooling, vocational training, higher education, and workplace learning. Despite this growing interest, challenges persist in effectively developing teachers' data literacy skills (Raffaghelli & Stewart, 2020). Teaching data literacy is further complicated by three



key factors: the continuous evolution of technologies and data sources, the shifting landscape of mathematics education, and the diverse contexts in which data literacy is applied.

Given these complexities, there is a pressing need to systematically examine the current state of data literacy in mathematics education. However, despite the increasing research interest, few systematic reviews have been conducted on this topic (Pinto et al., 2023). Therefore, this study aimed to provide a comprehensive systematic review based on a widely accepted framework to help educators and researchers better understand the current trends in data literacy in mathematics education and guide future teaching and research efforts.

#### Literature Review

Data literacy refers to teachers' ability to transform information into actionable instructional knowledge practices by collecting, assessing, interpreting various types of data, such as assessments, to guide instructional (Mandinach & Abrams, 2022). Henderson and Corry (2021) argue that data literacy and technology are inseparable, as many teachers have access to both qualitative and quantitative data through school or district-level databases. Learning information systems, learning management systems, and online testing platforms are among the key technologies that teachers must navigate to extract data and interpret visualizations effectively.

Machine learning and artificial intelligence (AI) systems play increasingly significant roles in data-driven decision-making, offering recommendations based on extensive data collected from learner keystrokes, progress tracking, and performance outcomes in digital learning environments (Ahmad et al., 2020). Consequently, data literacy is seen as an essential skill, enabling teachers to make well-informed and meaningful educational decisions (Pinto, 2023). In mathematics classrooms, teacher data literacy not only enhances student performance but also fosters an effective culture of teaching and learning.

Despite the recognized importance of data literacy, research suggests that many teachers lack confidence in their data literacy skills and do not perceive data-driven decision-making as useful. For example, a study conducted in the United States by Cowie and Cooper (2016) found that mathematics teachers were often uncomfortable with data literacy and hesitant to integrate data into their teaching practices, resulting in slow instructional improvement. In South Africa, Botha (2015) discovered that district-level decisions regarding interventions for underperforming schools

often exclude mathematics teachers, limiting their ability to analyze data, identify learning obstacles, and refine their instructional methods.

Developing teachers' data literacy skills requires structured professional development collaboration. Henderson and Corry (2021) found that teachers' data literacy improves when they engage in Professional Learning Communities (PLCs) that facilitate collaboration with peers from different schools. Additionally, strong data cultures and supportive leadership have been linked to increased data literacy competency among educators. Beck and Nunnaley (2021) argue that teachers should receive training in data literacy, assessment literacy, and mathematics instruction. Effective professional development programs should challenge teachers' existing perspectives on data use, equipping them with the skills needed to integrate data-driven insights into their teaching. Similarly, Burres et al. (2020) emphasize the need for school districts to establish policies that not only promote data literacy but also enhance teacher-to-teacher communication to foster collaborative data use.

While existing literature highlights the significance of data literacy in mathematics education, there is limited research on how mathematics teachers specifically engage with data literacy in their instructional practices. To address this gap, this systematic review aims to consolidate existing research on data literacy within the context of mathematics teaching and learning. By evaluating and synthesizing findings from various studies, the review seeks to clarify the role of data literacy in decision-making instructional in mathematics education. Additionally, it aims to identify current research gaps and propose directions for future studies to enhance the effective integration of data literacy in mathematics instruction.

#### **Research questions**

The present study addressed the following research questions;

- 1. What are the publication trends in data literacy research within mathematics education from 2009 to 2024?
- 2. What are the common research aims, data analytics tools, participant demographics, variables, and methodological approaches in studies on data literacy in mathematics education?
- 3. How does data literacy influence teachers' instructional decision-making in mathematics classrooms?



### Methods

This systematic review employed a rigorous approach to identify, select, and analyze relevant studies on data literacy in mathematics education. The review followed the Preferred Reporting Items for Systematic Reviews and Meta-Analyses (PRISMA) guidelines (Tricco et al., 2018) and incorporated bibliometric analysis to examine publication trends over time. The process involved defining inclusion and exclusion criteria, systematically searching databases using relevant keywords, screening and selecting studies, and categorizing findings based on key research themes.

## **Inclusion and Exclusion Criteria**

A set of inclusion and exclusion criteria was applied to ensure the relevance of selected studies. Only peerreviewed articles published in English between 2009 and 2024 were considered. Eligible studies explicitly addressed data literacy in mathematics education, including aspects such as data usage, data-driven decision-making, professional development, assessment, and school improvement. Studies focusing solely on higher education were excluded, as this review is concerned with primary school mathematics teaching and learning. Additionally, research that explored data literacy outside the context of mathematics education, as well as previous systematic reviews on related keywords, was excluded. After applying these criteria, 492 articles were selected for further analysis.

### **Search Strategy**

A systematic search was conducted across multiple academic databases, including Scopus, Web of Science, and Google Scholar. The search focused on publications from 2009 to 2024 and utilized various keyword combinations, such as "data literacy" AND "mathematics" AND "primary school" OR "elementary school". The initial search yielded 303 articles. After removing duplicates and conducting a thorough screening process, a total of 492 papers were identified for full-text evaluation.

To answer Research Question 1, bibliometric analysis was conducted to examine publication trends, key research contributors, and dominant themes in data literacy research within mathematics education. VOSviewer, a specialized tool for bibliometric visualization, was employed to analyze co-authorship networks, citation patterns, and keyword co-occurrences across the selected studies. This helped identify the most influential research contributions and thematic clusters in the field.

### **Screening of Included Articles**

A manual screening approach was employed to verify the relevance of selected studies. This involved a multi-step process, including title and abstract screening, followed by full-text review. The Revtools R package (Westgate, 2019) was used to eliminate duplicate bibliographic records and visualize article topics for efficient assessment. The PRISMA framework guided the screening process, and a PRISMA flow diagram was created to illustrate study selection, detailing included and excluded articles along with reasons for exclusion.

After applying all eligibility criteria, 14 studies were selected for final analysis. The included studies were categorized into two main themes: "Authors and titles of the articles" and "Study characteristics, including research aims, data analytics tools, common participants, methods, and key findings." This structured categorization provided a deeper understanding of how data literacy influences mathematics instruction (Moreno et al., 2018; Suyo-Vega et al., 2021).

# **Search Results**





Figure 1. PRISMA Flow Diagram of Study Selection Process

The PRISMA flow diagram (Figure 1) summarizes the selection process, highlighting the number of articles included and excluded at each stage. The primary objective of this systematic review is to identify and analyze studies that examine the role of data literacy in mathematics instruction and its influence on teachers' instructional decisions.

## **Results**

This section presents the findings of the systematic review in alignment with the research questions. The results are organized into two key areas: (1) Authors and titles of the articles, which provide an overview of the publication trends in data literacy research within mathematics education from 2009 to 2024, and

(2) Study characteristics, which analyze research aims, data analytics tools, participant demographics, methodological approaches, and key findings. By structuring the results in this manner, we aim to offer insights into the evolving landscape of data literacy in mathematics education and its impact on teachers' instructional decision-making.

### **Data Overview**



# Trends in Publications on Data Literacy in Mathematics Education (2009–2024)



To examine the publication trends on data literacy in mathematics education, we analyzed articles published between 2009 and 2024. The results are presented in Figure 2 and Figure 3.

Figure 1. Publication Growth in Percentage




The analysis reveals that there were no publications on data literacy between 2010 and 2011. This absence aligns with the relatively recent rise in scholarly interest in data literacy, which is closely linked to advancements in artificial intelligence (Michos et al., 2023). However, from 2016 onward, there has been a noticeable upward trend in publications, peaking in 2023 with 81 papers. This period (2016–2023) saw the publication of 200 papers on data literacy, indicating sustained research interest. The red line in Figure 2, labeled "Diff," represents the year-over-year percentage change in publications. Notably, there was a 10.12% increase in 2021 and a 12.55% increase in 2023, demonstrating growing scholarly engagement with data literacy research. Interestingly,

2024 shows a decline in publications, suggesting a potential research gap in data literacy and mathematics education that future studies could explore. Therefore, this analysis answers part of Research Question 1 by highlighting the volume and trend of publications on data literacy. The findings show a steady growth in research interest, peaking in 2023, but with a subsequent decline in 2024, signaling areas for further investigation.


# Research Aims, Data Analytics Tools, Participants, and Methods

This section presents findings addressing Research Questions 2 and 3. Research Question 2 examines research aims, data analytics tools, participant





demographics, and methodologies in studies on data literacy in mathematics education. Research Question 3 explores the impact of data literacy on teachers' instructional decision-making. The findings are structured into themes corresponding to each question for clarity (see Table 2). Table 2 summarizes the reviewed studies, including their research aims, data analytical tools, common participants, methods, and key findings.



The results of this systematic review were grouped into three clusters. The first cluster comprises studies focused on teachers' competency in data literacy. The second cluster includes studies examining the impact of data-driven decision-making interventions in the teaching and learning of mathematics. The final cluster consists of studies investigating teachers' perceptions and attitudes toward data literacy and its use in education.

**Cluster 1: Teachers' Competency in Data Literacy** The review revealed that teachers' competency in data literacy varies widely. Wu et al. (2021) assessed 531 pre-service teachers and found significant differences in their abilities to extract, represent, and interpret data. Similarly, Reeves and Honig (2015) reported that a six-hour intervention on data literacy led to measurable improvements in teachers' skills. Means et al. (2011) highlighted that confidence in data literacy influences teachers' ability to integrate data-driven decision-making into their instruction. Overall, the findings suggest that while some teachers have strong data literacy skills, many require targeted professional development to improve competency.

# **Cluster 2: Influence of Data Use on Instructional Decisions**

Teachers' data literacy significantly influences their instructional decisions. Studies by Benita et al. (2021) and Carlson et al. (2017) found that data-driven improves problem-solving, decision-making collaborative learning, and analytical skills among students. Van Geel et al. (2016) demonstrated that structured data-driven instructional approaches higher student achievement resulted in mathematics. Furthermore, Vahey et al. (2012) emphasized that teachers who integrate data literacy into lesson planning and classroom practices enhance student engagement and performance. These findings indicate that teachers with strong data literacy skills make more informed instructional decisions, ultimately benefiting student learning outcomes.

# Cluster 3: Teachers' Views on Data Use

Teachers' perceptions and attitudes toward data literacy play a crucial role in their instructional practices. Schildkamp and Kuiper (2010) found that teachers in the Netherlands actively use data to refine instructional strategies and track student progress. Schramm-Possinger and Harris (2021) reported that teachers' positive beliefs about data literacy, along with supportive school environments, encourage data-driven teaching. However, Cowie and Cooper (2018) noted that pre-service teachers often struggle with data literacy due to limited mathematical proficiency. Hoogland et al. (2016) emphasized the importance of collaboration and administrative

support in fostering positive attitudes toward data use in instruction. These findings suggest that while many teachers recognize the value of data literacy, continuous training and institutional support are needed to enhance their confidence and effectiveness in applying data-driven practices.

### **Discussion**

# Publication Trends in Data Literacy Research in Mathematics Education (2009–2024)

Our systematic review reveals a significant increase in research on data literacy in mathematics education over the past decade, particularly from 2016 onward, reflecting a growing scholarly emphasis on data-driven instructional practices. The observed peak in 2023 (81 publications) suggests heightened academic and policy interest, likely driven by the integration of artificial intelligence and data-based decision-making frameworks in educational settings (Michos et al., 2023). However, the absence of publications between 2010 and 2011 indicates that data literacy only recently emerged as a central research focus.

The fluctuations in publication volume, particularly the notable increases in 2021 (10.12%) and 2023 (12.55%), suggest a sustained interest and investment in data literacy research. However, the decline in 2024 raises critical questions about whether research momentum is slowing or if new challenges—such as methodological limitations, funding constraints, or shifts in research priorities—are emerging. Future studies should investigate whether this decline is a temporary fluctuation or signals a saturation of research themes that require new theoretical and empirical directions.

Furthermore, our findings highlight geographical disparities, with a dominance of Western contexts (e.g., the United States and the Netherlands) in data literacy research, while African and South American regions remain significantly underrepresented. This gap underscores the need for regionally contextualized studies that examine how data literacy is developed, perceived, and applied within diverse educational ecosystems. Without broader geographic representation, current research risks reinforcing Western-centric frameworks that may not fully address localized educational challenges and policy needs.

# Common Research Aims, Data Analytics Tools, and Methodological Approaches

The review identified several recurring themes in research objectives. Most studies focused on (1) assessing teachers' knowledge and perceptions of data literacy, (2) evaluating interventions designed to enhance teachers' data literacy, and (3) examining the



impact of data literacy on instructional decisionmaking.

Regarding methodologies, our findings highlight that quantitative approaches dominated (e.g., survey-based studies, experimental interventions), while qualitative investigations (e.g., case studies, ethnographic research) were relatively limited. This suggests a gap in in-depth, contextualized understanding of how teachers interact with data in real classroom settings. Additionally, studies varied significantly in terms of participant demographics, with most focusing on in-service teachers, while preservice teachers and school administrators were underrepresented. Addressing these gaps could provide a more holistic view of data literacy in mathematics education.

# The Role of Data Literacy in Instructional Decision-Making

The review confirmed that data literacy plays a crucial role in shaping teachers' instructional decisions, particularly in adapting lessons based on student performance data. Studies such as those by Means et al. (2011) and Van de Scheer and Vissecher (2016) found that teachers who received training in data-driven instruction were better equipped to modify teaching strategies and improve student outcomes.

However, not all findings were consistent. While some interventions led to significant improvements in teaching efficacy (Van de Scheer & Vissecher, 2016), others found no measurable impact on student achievement (Statman et al., 2017). This discrepancy suggests that simply training teachers in data literacy may not be sufficient—additional factors, such as school support structures, access to user-friendly data tools, and teachers' pre-existing beliefs about data use, may play a critical role in determining the effectiveness of data-driven instruction.

# **Teacher-Related Variables and Challenges in Data Literacy**

Our findings also highlight key teacher-related variables influencing data literacy development. Many studies (e.g., Reeves & Honig, 2015; Cowie & Cooper, 2018) reported significant gaps in teachers' foundational knowledge of data analytics. pre-service particularly among teachers. Additionally, studies revealed that teachers often struggle with interpreting complex data sets, limiting their ability to apply data-driven insights effectively. These findings underscore the urgent need for targeted professional development programs that go beyond basic statistical training to include practical, hands-on experiences with real classroom data. Moreover, research indicates that teachers' attitudes toward data literacy—whether they perceive data use as beneficial or burdensome—can significantly influence their willingness to engage with data tools. Addressing these perceptual barriers through ongoing support and mentorship could enhance the sustained adoption of data-driven practices in mathematics classrooms.

### **Implications for Educational Practice and Policy**

The findings of this systematic review highlight the importance of data literacy as a key component of effective mathematics instruction. Teachers who engage with data-driven decision-making demonstrate greater adaptability in their instructional approaches, which, in turn, enhances student participation and achievement. Schools should consider integrating data literacy training into professional development programs, emphasizing practical applications in mathematics classrooms to build teachers' confidence and competence in using data

Additionally, the review underscores the influence of data literacy interventions on teachers' willingness to engage with data-driven problem-solving. Educators who receive targeted support in data literacy are more likely to adjust their instructional strategies based on student performance insights. To sustain these improvements, policymakers should prioritize funding for teacher training programs that focus on data interpretation, common misconceptions, and best practices for integrating data into mathematics instruction.

Moreover, equitable access to data-driven resources remains a critical issue. Schools in disadvantaged communities often lack access to digital tools and training opportunities that facilitate effective data use. To bridge this gap, policymakers should allocate targeted funding to support under-resourced schools in implementing data-driven teaching strategies, ensuring that all learners benefit from advancements in educational data science.

# **Future Research Directions**

Although this review provides valuable insights, several gaps remain in the literature. First, most studies relied on self-reported data, which may introduce biases in measuring teachers' actual data literacy skills. Future research should incorporate longitudinal studies tracking how teachers' data literacy evolves over time and how sustained engagement with data impacts student learning outcomes.

Second, while quantitative studies dominated the field, there is a need for more qualitative and mixed-methods research to explore how teachers and students interact with data-driven instruction in real classroom settings. Further investigations should also examine how contextual factors—such as school



culture, access to technology, and administrative support—moderate the effectiveness of data literacy interventions.

Finally, more research is needed in underrepresented regions, particularly in Africa, South America, and Asia, where educational data literacy remains understudied. Expanding the scope of research will provide a more comprehensive understanding of how data literacy practices can be adapted to different educational contexts worldwide.

### Conclusion

This systematic review highlights the growing significance of data literacy in mathematics education, particularly in shaping teachers' instructional decisions and improving student outcomes. Despite its potential, data literacy remains an emerging field with limited empirical research, particularly in non-Western educational contexts. To address the existing gaps, future studies should focus on long-term impacts, diverse methodological approaches, and regional disparities in data literacy adoption. Advancing data literacy education as a structured research domain will be essential in ensuring that teachers and students can fully benefit from data-informed instructional strategies in mathematics.
