Many schools in the region lack modern laboratory equipment, making it difficult for students to conduct necessary experiments. Recommendations

These recommendations focus on research design, implementation, policy, and community engagement:

1. Conduct a Baseline Needs Assessment

Objective: Understand the current state of biology education and technological readiness. Survey stakeholders (teachers, students, principals) to assess: availability of digital infrastructure (computers, internet access), teachers' digital literacy and openness to AI tools, students' exposure to or interest in digital learning, analyze WAEC/NECO biology results over the past 3 to 5 years to establish academic performance trends.



2. Design Pilot AI-Integrated Biology Programs

Objective: Implement small-scale AI solutions to evaluate effectiveness.

Introduce AI-based tools such as: Intelligent tutoring systems (e.g., Century Tech, Squirrel AI) for individualized learning, Voice assistants and chatbots for answering biology-related questions, Visual recognition tools (e.g., AI microscopes, Google Lens) to assist in learning about anatomy, plant species, and microorganisms.also, the use interactive platforms such as: Khan Academy with AI tutors (Khanmigo) for supporting human biology topics, Edmodo, Quizizz, or ChatGPT-based solutions for test prep and instant feedback.

3. Train Biology Teachers on AI Tools

Objective: Build teacher capacity to integrate AI into lessons.

Organize workshops in collaboration with Jigawa State Ministry of Education, NGOs or tech companies (e.g., Teach For Nigeria, Mind the Gap). Federal College of Education (Technical) Bichi or Bayero University, Kano.

Training areas should include: the Basics of AI and educational technology, how to integrate AI into the biology curriculum (e.g., cell biology, ecology, genetics) and use of data dashboards to monitor student progress.

4. Establish Research Framework to Monitor Impact

Objective: Measure the impact of AI integration on biology learning outcomes.

Use a quasi-experimental design: to create experimental and control groups of schools, measure academic performance, engagement and interest in biology before and after AI tool usage. Collect qualitative data via focus group discussions with students and teachers, classroom observations, teacher reflective journals. Also, use analysis tools like SPSS or NVivo for mixed-methods evaluation.

5. Improve Digital Infrastructure in Pilot Schools

Objective: Provide enabling environment for effective AI integration.

Recommend government and private sector support to supply solar-powered devices (due to frequent power outages), provide affordable internet access in schools (e.g., through EduNet by NITDA) and also advocate for inclusion of digital biology content in local curriculum plans.

6. Foster Community and Policy Engagement

Objective: Ensure local support and policy alignment.

Host town hall meetings with parents, local chiefs, and religious leaders to promote the benefits of AI in education.

Encourage Jigawa State Universal Basic Education Board (SUBEB) to incorporate AI strategies in educational policy. Include AI literacy and ethics in the biology curriculum as a pilot topic.

7. Promote Inclusive Access to AI Tools

Objective: Ensure equity in AI integration.

Prioritize girls' schools and rural schools in AI interventions to close the gender and digital divide and provide multilingual AI tools or translation support for Hausa-speaking students to ensure understanding.

8. Partner with Institutions and Tech Startups

Objective: Sustain and scale AI innovations.

Collaborate with National Information Technology Development Agency (NITDA), NGOs like eLIMU, Onebillion, or Andela for curriculum support. Local teacher colleges for continuous professional development.

9. Document and Disseminate Best Practices

Objective: Share knowledge and inform scale-up.

Publish findings in academic journals and present at education technology conferences in Nigeria and encourage Ministry of Education to replicate successful models in other LGAs.

10. Develop Localized AI Content

Objective: Ensure relevance to local syllabus and context.

Create AI-assisted resources aligned with Nigerian Secondary School Biology Curriculum (NERDC) and develop gamified and culturally relevant biology modules using AI storytelling and simulations.

Conclusion

The integration of AI into Biology education presents a transformative opportunity to enhance learning outcomes, improve accessibility, and promote scientific inquiry among students. AI-powered learning tools, such as virtual labs, intelligent tutoring systems, and automated assessments, can help bridge the gaps in traditional teaching methods by offering personalized and engaging learning experiences.
